It is to bring to the notice of the trade that Central Board of Excise and Customs vide Notification No. 02/2017-Central Tax dated 19.06.2017 has specified the jurisdiction of Central Tax & Central Excise Commissionerate, Chandigarh under the Zonal charge of Chief Commissioner of Central Tax & Central Excise Zone, Chandigarh as under:

The jurisdiction of Central Tax & Central Excise Commissionerate, Chandigarh will be the Union Territory of Chandigarh.
